Accomplishments in 2015

Automated Phone System—In April the District implemented an automated phone system to provide water right priorities that are able to divert based on the amount of available water. Since its implementation there have been 84 incoming calls. In our estimate (at 10 minutes per call had the Watermaster been contacted instead) the use of the automated system has saved approximately 14 hours of work by the Watermaster.

Cost of Service—During 2015 two important changes have taken place in regards to how the SSWD developed the annual budget and cost apportionment. The previous method of having a separate budget for each service area created a large disproportionate share of the cost between service areas. The Board of Directors determined that a single District-wide budget equally distributes costs across service areas to create a balanced approach for the same service. Secondly, The Board of Directors reviewed the minimum cost requirements necessary to sustain the operations of the SSWD. This amount has been determined to be about \$27,000 annually and includes all administrative tasks and direct expenses (i.e. insurance, financial audits, printing, etc.). Again, to create a balanced approach for charging this amount the Board has approved a 'flat fee' method of cost apportionment as allowed by the Order for Substitution of Watermaster Service. This means each diversion owner is now charged a flat fee to equally share in the cost to cover the administrative amount. This method has been determined to be the best approach for meeting the minimum financial needs of the SSWD and to proportionately distribute the share of cost. The flat fee amount will be re-evaluated every three years to determine if it continues to meet operational needs. The remaining budget amount (for non-administrative services) is charged based on individual water rights in cubic feet per second (cfs) as calculated by the Deputy Watermaster.



Fee Waiver Available for Qualified Diversions

Water right owners within the jurisdiction of the Scott Valley and Shasta Valley Watermaster District (SSWD), who pay an annual watermaster service fee, and wish to be considered for a waiver of this fee must submit a *REQUEST FOR WAIVER OF WATER-MASTER SERVICE FEE* form, with signature, during the annual **Fee Waiver Enrollment Period of March 1st through April 15th** along with a payment of \$60 to cover the cost of verifying the diversion and water right qualifies for the waiver. Eligibility is determined by the Deputy Watermaster. All requests for fiscal year 2016-2017 will be considered at the Board of Directors' meeting held on May 25, 2016.
